We are involved in the collection of raw materials such as: scrap, non-ferrous metals, waste paper, foil, PET bottles and glass as well as waste electrical and electronic equipment. We receive industrial and hazardous waste. We deal with the recovery and recycling of packaging, batteries and accumulators, and also act as an 'introducer' (an importer, producer, intra-community acquirer) related to the organisation of the collection, processing, recovery

and recycling of waste electrical and electronic equipment.

We have all the required permits and permissions regarding the collection and transport of waste. We also deal in the marketing of steel and the production of reinforcements for construction purposes.

► Since the year 1990, the company has constantly strengthened its position on the market of raw materials as well as in the field of problematic and packaging waste. Its constant development has resulted in the establishment of field divisions on the territory of Western Poland. At present, we provide services to over 4,700 business partners from the B2B sector, using logistic facilities located on eight reloading yards in Poland.

The waste entrusted to us is managed in a manner that is safe for the health and life of humans and the natural environment.

As a waste recipient provided with all the permits required by law, we offer to take over your obligations arising from the Waste Act of December 14th, 2012. Smooth cooperation with our clients is ensured by our extensive and experienced Environmental Protection Department.

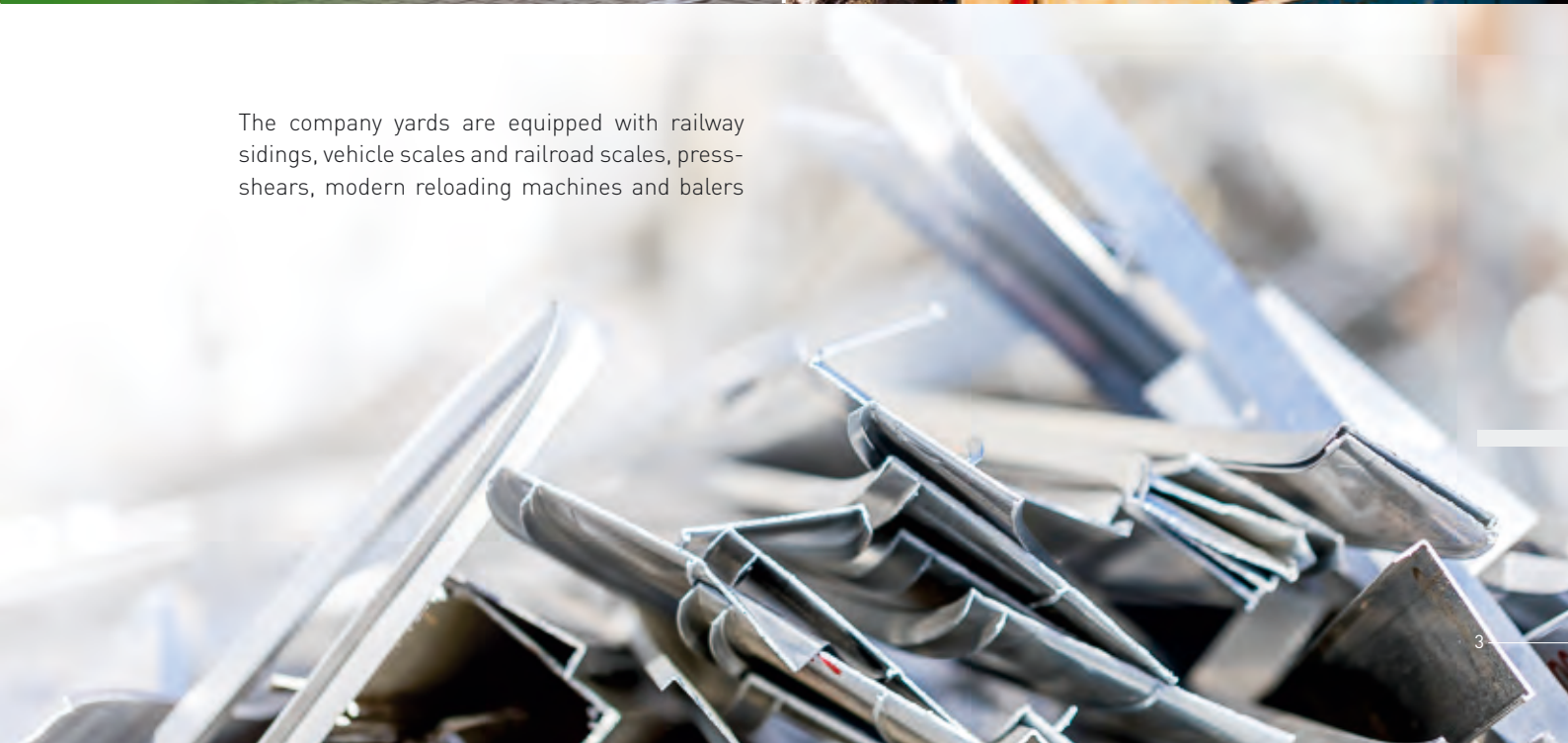
TOM Sp. z o.o.

The company has an extensive vehicle fleet and a machine park at its disposal. The transport fleet consists of specialist vehicles with their own loading systems as well as a broad range of containers for the transport of waste.

The secondary raw materials are recovered, mainly through the use of our own containers with capacities ranging between 12 and 33m³, as well as press containers, of which our company is in possession of over 1,500.

Tom Sp. z o.o. is a reliable and proven producer of reinforcements for construction purposes as well as a supplier of metallurgical products. The company is also involved in the production of spatial figures such as columns, beams and piles. At our headquarters in Szczecin we also own a modern machine park ensuring the production of high quality elements of any shape. The monthly

production capacities of the steel yard amount to 4,000 tonnes of output. We have about 12,000 tonnes of steel on constant sale at our warehouses. We achieve sales volumes exceeding 100,000 tonnes of steel per year.





Production process

The production process is implemented using specialist software which ensures efficient logistics. An additional advantage is the qualified engineering-technical staff, which guarantee comprehensive and reliable service.

The stable financial situation, high output capacity and experience of our staff enable us to apply for even the biggest contracts. Our clients come from all over the country and include many market-leading commercial and production companies.

domestic and foreign recyclers whose permits for waste recycling and recovery have been checked and validated, and their activities are verified on an annual basis by the authorities of the environment protection inspectorate.

By virtue of the act on batteries and accumulators, on behalf of businesses which market batteries and accumulators, we perform the duties of their collection, processing, recovery and disposal.

TOM-DOLEKO-EKOLA Organizacja Odzysku Opakowań SA is an entity which is responsible for the operational and technical aspects of the implementation of the agreement between the Northern Chamber of Commerce and the Marshal of the West-Pomeranian Province ensuring the recovery and recycling of packaging waste produced from multi-material packaging and the preparation of all the required reports related to this obligation.

Both the agreement and other services rendered by the organisation cover clients who run their operations nation-wide.



Education

The main subject of the organised Public Educational Campaigns are activities related to improvements in the effectiveness of the collection of waste electrical and electronic equipment, as well as the proper handling of packaging waste.



Our educational activities can be categorised into four main areas:

I. Conferences on Environment Protection Law.

Every year we organise a cycle of full-day meetings regarding environmental protection law for our business partners. The issues discussed during these conferences refer to environmental protection law in those areas served by recovery organisations (packaging, batteries, electrical and electronic equipment). Additionally, subjects which are not directly related to the obligations of those organisations are touched upon, i.e. waste, emissions, records and reporting.



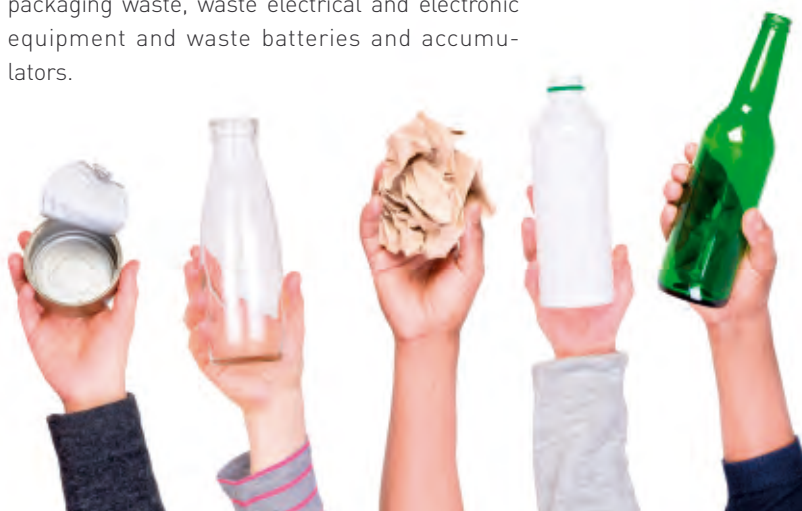
For each conference, we ensure the presence of the best specialists in the industry. Participation in the conferences is the area of ecological education most frequently used by our business partners. The conferences may be attended without paying any extra fees.



II. Activities which support the marking out of the waste and resources management areas (water/ electricity) at a company. This serves the purpose of improving the effectiveness of waste management, as well as the limitation of waste generation. This area is used mainly in the handling of the receipt of raw materials and waste, by companies which are part of the TOM Group, from production plants.

IV. Ecological picnics during mass events. Our organisations have the technical resources at their disposal to participate in such events. By means of a mobile ecological education stand we teach the public about waste through the organisation of games and entertainment activities for children and adults. Our activities are focused on shaping and supporting initiatives aimed at building pro-ecological attitudes. The purpose of our campaigns is to broaden the knowledge of local communities with regards to rational and environmentally friendly waste management, with a particular focus on the strengthening of proper behavioral patterns related to the handling of packaging waste, waste electrical and electronic equipment and waste batteries and accumulators.

III. Educational workshops at schools are mainly directed at 3rd and 4th grade pupils in primary schools. The workshops take the form of a lecture combined with a display of multimedia materials regarding recycling. The pupils participating in the workshops, owing to the gained knowledge, receive the status of School Recycling Leaders. The authors and lecturers during the classes at schools are specialists from the waste management industry. All of the classes conducted give rise to a number of ecological initiatives associated with selective waste collection.
